Voting

Please note that you cannot vote by returning this notice.

There are several ways you can vote your securities before the meeting:

- If you are a **registered securityholder**, you can attend the meeting and vote in person. If you are not planning on attending the meeting, you can vote by proxy. For additional details regarding voting by proxy, please see under the heading "*Voting and Proxy Information - How to Vote*" in the Circular. **TSX Trust Company must receive your vote before 9:00 a.m. (Mountain Time) on April 24, 2023.**
- If you are a **beneficial shareholder**, please use the voting instruction form (or similar form) provided by your intermediary. For additional details please see under the heading "*Voting and Proxy Information - How to Vote - As a Beneficial Shareholder*" in the Circular. **Your intermediary must receive your voting instructions well in advance of the meeting in accordance with the instructions set out in your voting instruction form.**

You may also vote during the meeting. Unless you intend to vote in person during the meeting, we encourage you to vote as early as possible using the enclosed form of proxy or voting instruction form so that your securities are represented at the meeting.

Upon request, we will provide a paper copy of the meeting materials to any securityholder, free of charge, for a period of one year from the date the Circular was filed on SEDAR. Here is how you can request a paper copy.

AFTER THE MEETING

If your request is made before April 26, 2023 (the date of the meeting), the meeting materials will be sent to you within three business days of receipt of your request. If the request is made on or after April 26, 2023, the meeting materials will be sent to you within 10 calendar days of receiving your request.

To ensure receipt of the paper copy in advance of the voting deadline and meeting date, we estimate that your request must be received by us no later than 4:00 p.m. (Mountain Time) on April 18, 2023.
